This is an enhancement to our existing Student Care Takaful's coverage which is in line with the requirement of the Prime Minister's Office of Brunei Darussalam in relation to medical insurance/takaful coverage for students pursuing their studies abroad.

This coverage is extended to cover Medical Expenses Abroad due to COVID-19.
